## FCCMA 2014 Annual Conference Case Study Submittals - One Week Left for Submittal

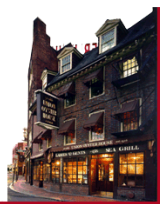


There is only one week left to submit a case study for consideration as a session at the annual conference.
