Municipal Parking Meters on State Right-of-Ways Request for Information

During the 2014 Legislative Session, the Florida Legislature passed and the



Governor signed into law HB 7175, a transportation bill. HB 7175 provides that on or before August 31, 2014, each municipality and county that receives revenue from any parking meters or other parking time-limit devices that regulate designated parking spaces located within or along the right-of-way limits of a state road, is required to provide the Florida Transportation Commission (FTC) a written inventory of the location of each meter or device and the total revenue collected from those locations during the last three fiscal years. In addition to the written inventory, each municipality and county will inform the FTC of any pledge or commitment by the municipality or county of revenues to the payment of debt service on any bond or other debt issued by the municipality or county.
