ICMA Code of Ethics Tenet 12



Leaders at the Core of Better Communities

On March 2, ICMA members received an email related to the proposed changes to ICMA Code of Ethics Tenet 12. For the past year, the ICMA Committee on Professional Conduct

(CPC) has been reviewing Tenet 12. Members were asked their opinion on Tenet 12 in face to face discussions at Regional Summits and State Meetings throughout 2014. Additionally, the Committee asked members to complete a survey in order to provide them with additional input on language in Tenet 12. A large number of ICMA members participated by attending the face to face sessions and completing the survey.

The ICMA Executive Board received a report from the CPC and voted to refer the Tenet 12 proposed change to the membership. In order to change the Tenet language a vote of membership is required. What the CPC has proposed is to update the language. The language of this Tenet was adopted in 1972. ([Read more](#))
