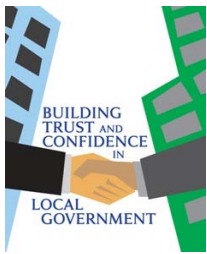

### FCCMA Ethics Webinar Series, Part 2

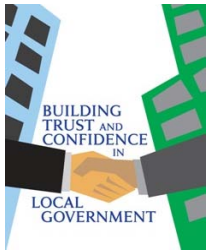


This is the second webinar of a two-part webinar series. All FCCMA webinars are free.
