## **FSU Selected by FCCMA Board for "Florida Center for Excellence in Local Public Management"**

On October 12<sup>th</sup>, following interviews with both finalist schools (FSU and UCF), the FCCMA board of directors selected Florida State University as the school to administer the "Florida Center for Excellence in Local Public Management." The Board will now enter into a letter of agreement with FSU, through the Askew School of Public Administration and Policy. The Askew School and FCCMA will also create an implementation timeline.

Commenting on the process, President Feldman commended the Site Visit Team and Task Force, chaired by past president William Whitson, and added: "We are very excited about this program and look forward to working with FSU on an agreement. Both UCF and FSU made excellent proposals and presentations - it was not an easy decision. This program will greatly benefit the next generation of Florida's local public managers and will provide an exciting forum for our members in which to gather and solve problems."

## **Emerging Professionals Symposium – Public Management: The Tapestry of the Profession**

On Friday, October 13, 2006 the Florida City and County Management Foundation (FCCMF) presented the Emerging Professionals Symposium. The fall symposium is designed for the up and coming leaders of the profession – students, professionals beginning their careers, and department directors. Seasoned professionals also attend to add to their credentialing hours. This year's symposium had the highest attendance yet! It is the goal of FCCMF to increase attendance every year and continue to reach out and educate government employees on the opportunities available to them. The speakers were excellent, and

### **2007 Winter Institute, St. Augustine—February 8-9**

Registration materials are being printed the week of October 16, and they will be posted on the web and mailed to managers and assistants. The Winter Institute is limited to 80 participants so be sure to sign up early. It is also limited to managers and deputy/assistant managers.

The Winter Institute will focus on “systems and critical thinking”, led by Dr. Ray Jorgensen of the Jorgenson Learning Center. Dr. Jorgenson’s work on systems thinking has been discussed in the book, *The Fifth Discipline*, by Peter Senge. This year’s program will begin Wednesday evening, February 7, with a reception. Class begins early Thursday morning with an overview and keynote address by Dr. Jorgensen. Several JLC associates will assist, and there will be a good deal of interaction. Cost to attend is \$325 for the one and a half-day session, which includes continental breakfasts and lunch on Thursday.

### **2007 Annual Conference – *The Challenge of Change: Creating and Sustaining Leadership Capacity*—Bill Strickland Signed as Opening Keynote Speaker**

FCCMA has signed a contract for the keynote address on Thursday, May 17. Bill Strickland, President of Manchester Craftsmen’s Guild and the Bidwell Training Center will speak about his remarkable journey turning a near bankrupt community training center in Pittsburgh into one of the most successful organizations in America. He will “restore one’s faith in ethical, accountable and visionary leadership.” Mr. Strickland has received a MacArthur Genius grant, lectured at the Harvard Graduate School of Education and served on the Board of the National Endowment for the Arts. He has been recommended as “a most inspiring human being and mesmerizing speaker...”

This year’s conference will be at the Doral Golf Resort and Spa from May 16-19, 2007. Once again, the popular “So You Want To Be A City/County Manager” pre-conference session will be offered on Wednesday the 16<sup>th</sup>. This is a free session, so if you have any entry-level employees or department heads or know of any students who may be considering a position as a manager or assistant manager, please encourage them to attend. A legislative update will be planned, as the legislative session will have just concluded. There will be a stand-alone session to showcase the Center for Excellence for Local Public Management. Friday night’s social event will have a “Goombay” festival theme and should be lots of fun. Registration information will be available in early February and posted on the web site.
