Background

Obesity rates in the U.S. have increased dramatically over the last 30 years, reaching epidemic proportions. Obesity increases the risk for many serious health conditions, including heart disease, stroke, high blood pressure, type 2 diabetes and cancer. Obesity and associated chronic diseases have a considerable economic impact on

communities and individuals, especially where availability and access to healthy foods and healthy spaces for physical activity are limited.

In Florida, only 33.9 percent of adults are at a healthy weight. In addressing this issue, the Florida Department of Health created the Healthy Community Champions Recognition Program.
