What was your last position before becoming an MIT?

A recent example is the certified completion of the High-Performance Leadership Academy, a 12-week online program created to equip local government professionals with leadership skills in organizational development and change management, negotiations and collaboration, effective communication, and how to deliver increased value from high-performance management.

My expertise lies in public policy and managing human behavior to cultivate organizational success. Whether involved in executive coaching, visioning and strategic goal setting, negotiations and labor relations, conflict management, or any other aspect of leadership, I navigate mindfully, using listening skills and keeping word selection at the top of mind. 

Why did you select a career in public service?




Program Summary:
