

I'm a credentialed manager by ICMA, a retired U.S. Reserve veteran, and a senior-level executive with 31 years of experience in governmental and private sectors.



## Meet Richard Collins, Emergency Services Director, Sarasota County

## How long have you been an FCCMA member, and why did you join?

I have been a member since 2018.

## Are you an ICMA member? Why did you join, and how long have you been a member?

Yes, since 2018. I have been in public service for over 30 years, and in the past several years I have looked to grow beyond public safety into a greater leadership role in local government.

#### Please describe your areas of formal/advanced

#### education.

Bachelor's degree in organizational management from Palm Beach Atlantic University. Master's degree in organizational leadership from Palm Beach Atlantic University. Also hold Florida professional emergency management certification.

#### Why did you select a career in public service?

My family has an extensive history of service, especially in public safety. My father worked as an EMT and volunteer firefighter. He also served in the Air Force Reserves, and we would regularly go with him when he did his annual training. These experiences left me with a desire to serve in the military and pursue public service. I started my career by joining the Air Force Reserve as a flight medic, and ultimately that background led me to the fire service.

## Have you always been in the public sector, or have you had experience in the private sector?

Before joining the Air Force, I worked at a hospital and trauma center. During my career, I have also assisted my wife in forming a design firm. My role included representing the firm in gaining new clients, managing clients and various other support. We also did consulting in areas of emergency management. While we did not have employees, we did use contractors for specific needs, depending upon the project.

## Please tell us about your current position and give a brief job description if you are not a City Administrator/Manager.

I serve as the Director of Emergency Services for Sarasota County. Emergency Services has 630 employees serving across four main divisions including the Fire Department, Lifeguards, Emergency Management and Public Safety Communications. The majority of the team members work in the Fire Department where we have 25 fire and EMS

stations. My job is to provide leadership, strategic direction and support to the various division managers. During disasters I work directly with County administration to ensure successful response and recovery across the community.

#### **Let the Sunshine In**

"The FCCMA Podcast" series has revealed a virtual treasure trove of individual nuggets of insight, history, wisdom and hard-earned experience in our field. Host **Steve Vancore** has reached into the collective experience of nearly 100 professionals (as of this writing) and documented what amounts to an amazing oral history for our organization.

Steve has asked quite a few of his interview subjects some version of these questions: "What would you tell managers from other states who are coming to work in Florida for the first time. What do they need to know first?" In contrast to the level of diversity of opinion and perspective the podcasts typically represent, the answer to those questions has been nearly universal: "I would tell them about our Sunshine Laws!"

The follow-up to this answer quite often encompasses some level of lamentation about the cumbersome nature of Florida's open meetings law and the intrusiveness of Florida public records law. We city and county managers may love our Sunshine State, but it's fair to say that, as a group, we're less enamored with our "Government in the Sunshine" manual. Is there a manager anywhere in Florida who hasn't heard this lament from a newly elected council member or who hasn't at some point joined the chorus right along with them?

Consider then another point of view. What if rather than treat these mandates as inconveniences, we use them as building blocks to support a value system that truly embraces transparency and by extension transparency's first cousin, accountability? It is reasonable to argue that an organization with a high commitment to transparency not only inspires the trust of its constituents but is held in higher esteem by them as well. In fact, in the private sector many have argued exactly that.

#### **2023-2024 Photo Contest**



The winning entry for the 2023 Florida City and County Management Association (FCCMA) Photo Contest was submitted by the City of Panama City Beach. The City turned its entry into a contest, asking residents and visitors to submit a photo that best depicted life in Panama City Beach. They received 50 entries, with the winning photo selected by the Mayor and City Council.

Many commented that the photo has an old Florida vibe. It was taken in July 2022 on the Russell-Fields City Pier, looking back toward Pier Park. The photographer is Tracey Miller of Ontario, Canada, living in PCB, as her husband is part of the Canadian Detachment assigned to Tyndall Air Force Base.

The winning FCCMA entry competed against 36 other entries and received 1,206 votes. The emerald waters, white sandy beaches and breathtaking sunsets showcase the allure of Panama City Beach to the 4.5 million people who visit each year. The tagline "Home of the World's Most Beautiful Beaches" is not a statement argued by those who live here or have visited.

Like many communities in Florida, tourism is the City's number one industry, and this photo captures beachgoers enjoying the sandy beach, with the City's largest retail hub, Pier Park, pictured in the background. The City has a booming local economy, primarily consisting of hospitality, food service, specialty shops and other small businesses. The city pier is also a large tourist attraction, with more than 310,000 visitors each year. At 1,500 feet, it is one of the longest piers on the Gulf and offers both great fishing and breathtaking views. The Pier never closes and is open year-round.

Incorporated in 1970, Panama City Beach has no true Main Street, but this area around the Pier along Front Beach Road comes close, as it is a hub of activity and the home of numerous concerts, festivals and other special events at nearby Aaron Bessant Park.

Last year, the City Council approved a contract with a private entity to redevelop the Pier and boardwalk. Decking will be replaced, restrooms upgraded, and a new building will feature rooftop views and entertainment options. The redevelopment will strengthen the area's appeal as a destination.

Strategic management is the management of an organization's resources to achieve its goals and objectives. It involves setting

objectives, analyzing the competitive environment, analyzing the internal organization, evaluating strategies and ensuring that management rolls out the strategies across the organization.

In practice, organizational leaders focus on learning from past strategies and examining the environment at large. The collective knowledge is then used to develop future strategies and to guide the behavior of employees to ensure that the entire organization is moving forward. For these reasons, effective strategic management requires both an inward and outward perspective.

Managing change and ambiguity requires strategic leaders who not only provide a sense of direction but who can also build ownership and alignment within their workgroups to implement change.
