Establishing trust requires building relationships before they are needed. Hosting local events such as fundraisers, holiday gatherings, and recreational activities can bring people of differing viewpoints together. Governments should be accessible, transparent, and deeply involved in their communities, keeping promises to build a track record of reliability. When trust is established, civil interactions are more likely to occur—people are more inclined to listen and less likely to act with suspicion or hostility when they believe in the motives and sincerity of others.
